

The Croswell City Council met in Special Session August 13, 2012, at Croswell City Hall, 100 N. Howard Ave., Croswell, MI. Mayor McMillan called the meeting to order at 5:20 P.M.

I. BUSINESS:  
a. Union Contract:

Utility Workers Union agreed to the additional language for the compliance with Public Act 152 of 2011.

Geiger moved to approve the Utility Worker Union Contract for July 1, 2012 to June 30, 2015, second by Butler.

Roll Call Vote: Geiger, yes; Butler, yes; Willis, yes; Krawczyk, yes; McMillan, yes. 5 yeas, 0 nays.  
Motion Carried.

Due to the Utility Workers contract settled.

Butler moved to add the Electric/Water Supervisor Agreement; EMS Director Agreement and the Fire Chief Agreement to the agenda, second by McMillan.

Roll Call Vote: Butler, yes; McMillan, yes; Willis, yes; Krawczyk, yes; Geiger, no. 4 yeas, 1 nay.  
Motion Carried.

b. Agreements:  
i. Electric/Water Supervisor:

Butler moved to approve the Electric/Water Supervisor agreement with employee only health coverage and no compensation increase, second by Krawczyk.

Discussion was held regarding the offering of employee only insurance.

Roll Call Vote: Butler, yes; Krawczyk, yes; Willis, yes; Geiger, no; McMillan, yes. 4 yeas, 1 nay.  
Motion Carried.

ii. EMS Director:

McMillan moved to approve the EMS Director Agreement with employee only health coverage and no compensation increase, second by Willis.

Discussion was held regarding third party billing services.

Roll Call Vote: McMillan, yes; Willis, yes; Krawczyk, yes; Butler, no; Geiger, no. 3 yeas, 2 nays.  
Motion Carried.

iii. Fire Chief:

Willis moved to approve the Fire Chief Agreement for the period of July 1, 2012 to December 31, 2012, second by Butler.

Discussion for the contract to end December 31st each year, fire department appoints Fire Chief by the calendar year.

Roll Call Vote: Willis, yes; Butler, yes; Krawczyk, yes; Geiger, yes; McMillan, yes. 5 yeas, 0 nays.  
Motion Carried.
